

Request for Refund of Duty on Registration of Replacement Motor Vehicle

Note:

- Under the *Taxation Administration Act 1996*, it is an offence to give false or misleading information.
- This form is only to be used for vehicles purchased to replace vehicles that were destroyed during a declared natural disaster.
- A list of 'Current Natural Disaster Declarations' by Emergency NSW can be accessed from the Revenue NSW website www.revenue.nsw.gov.au/taxes/vehicle/natural-disaster
- If your destroyed vehicle was **comprehensively insured**, the amount you'll receive will be the duty payable on the lower of:
 - The cost of the replacement vehicle, or
 - The value of the insurance payout for the vehicle written off.
- If your destroyed vehicle was **not comprehensively insured**, the amount you'll receive will be the duty payable on the lower of:
 - The cost of the replacement vehicle, or
 - The value of the destroyed vehicle.
- All evidence must be provided for your application to be considered. Failure to provide this evidence will result in your application not being processed.
