

Application for Exemption or Refund – Break-up of a Domestic Relationship

Important Message: From 1 January 2016, refunds will be issued by Electronic Funds Transfer (EFT) only. If you are applying for a refund you must complete the 'EFT Details' section of this form.

Note:

- This declaration **must** be completed by one of the parties to the domestic relationship
- Exemption is conditional on the Chief Commissioner being of the opinion that the domestic relationship has been terminated
- Please complete Section B for a transfer of a motor vehicle registration (refer Section 267(7))
- Please complete Section C to apply for a refund of duty paid on a transfer, agreement for sale or transfer or the transfer of a motor vehicle
- The evidence required to substantiate a claim for exemption or refund is outlined under each section of this form. **All evidence must be provided for your application to be considered.** Failure to provide this evidence will result in your documents being returned unprocessed.
- This form must **not** be used for the break-up of a marriage or de facto relationship, use form ODA 069
